- 2021 Activities
 - Paper reviews

 - Research subcommittee – Greg Giaimo, Ohio DOT, Vince Bernardin, Caliper, Jeremy Raw, FHWA, Rob Schiffer, FuturePlan Consulting, Rob Bostrom – focus on Peer Exchange
- 2022 Annual Meeting related activities
 - TRB liaison – Anusha J.
 - 9k registered but not sure of the final count
 - Exec committee working on how transportation serves broader society goals (safety and security, climate changes, public health, and equity,
 - Strategic update
